Objectives and investment policy

The Fund aims to achieve both capital and income growth by investing in any country and any economic sector of the world.

The Fund may predominantly invest in:

• other investment funds.

The Fund may also invest directly or indirectly in:

- transferable securities (includes but not limited to shares, bonds issued by governments and other organisations)
- warrants
- · cash, money market instruments and deposits
- gold.

The Fund may use derivatives for Efficient Portfolio Management (EPM), i.e. to protect against market or currency movements, to reduce costs, or to earn income or capital. The Fund may use derivatives and forward transactions for investment purposes on the giving of 60 days' notice to Shareholders. The use of derivatives for investment purposes may alter the risk profile of the Fund.

Net Income shares: Any income the Fund generates will be paid out to you.

Net Accumulation shares: Any income the Fund generates will be reinvested.

You can buy and sell shares on the 14th day and the last business day of the month except where the 14th is not a business day when it shall be the next business day.

The Fund is actively managed, which means that the manager has discretion over the composition of its portfolio, and the Fund is not tracking a benchmark nor is the Fund constrained by the value, price or components of a benchmark or any other aspect. The Fund is also not aiming to match or exceed the return of any benchmark.

Risk and reward profile


