The Fund is a sub-fund of Starhunter Investments Fund.
The Authorised Corporate Director of the Fund is Evelyn Partners Fund Solutions Limited, part of the Evelyn Partners group.

Objectives and investment policy

The Fund aims to generate capital growth over the long term (at least 7 to 10 years).

The Fund is a multi-asset fund meaning that it will have exposure, mainly through collective investment schemes (which may include those managed by the ACD), to a range of asset classes.

The Fund is not constrained by any particular asset allocation in respect of geography, industry or sector.

In normal market conditions 50%-85% of the Fund will typically be invested in shares.

The Fund may also invest, directly or indirectly, in:

- bonds issued by governments and other organisations
- other investment funds
- cash, near cash, deposits and money market instruments
- gold, however exposure to gold will be through exchange traded funds

The Fund operates an exclusions policy and will not invest in companies (directly or indirectly via collective investment schemes) that derive a significant proportion (generally defined as 5%-10%, but this value may change over time) of their revenue from defence and weapons, tobacco and alcohol related activity, carbon and fossil fuels (or the production and extraction thereof), gambling or all forms of slavery.

The Fund may use derivatives and forward transactions for Efficient Portfolio Management (EPM), i.e. to protect against market or currency movements, to reduce costs, or to earn income or capital.

Income Shares: Any income the Fund generates will be paid out to you.

Accumulation Shares: Any income the Fund generates will be reinvested.

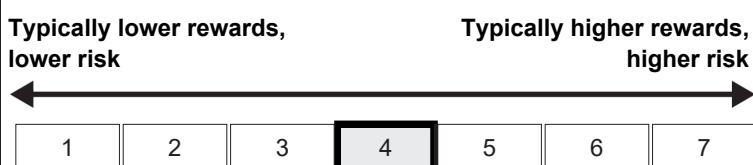
You can buy and sell shares on the 15th day and the last Business Day of the month except where the 15th is not a Business Day when it shall be the next Business Day thereafter.

The Fund is actively managed, which means that the manager has discretion over the composition of its portfolio, and the Fund is not tracking a benchmark nor is the Fund constrained by the value, price or components of a benchmark or any other aspect. The Fund is also not aiming to match or exceed the return of any benchmark.

Risk and reward profile

The Risk and Reward Indicator table demonstrates where the Fund ranks in terms of its potential risk and reward. The higher the rank the greater the potential reward but the greater the risk of losing money. Charges

- The ongoing charges figure is estimated because the share class has insufficient track record for us to calculate it exactly as at 14/04/2023. The ongoing charges figure may vary from year to year and will exclude the costs of buying or selling assets for the Fund (unless these assets are shares of another fund).
- The ongoing charges figure is a representation of the charges taken from the Fund over a year. The estimated ongoing charge of 2.05% is based on the actual Annual Management Charge (AMC) of 1.15% at launch. Should the maximum AMC of 1.50% be charged in future, the estimated ongoing charges figure would be 2.40%.
- Previously, the Ongoing Charges Figure (OCF) included expenses incurred by a Fund on any investments in collective investment schemes and closed ended vehicles such as investment trusts (the synthetic OCF). Following guidance issued by the Investment Association on 30 November 2023, any synthetic OCF calculated after this date will no longer include closed ended vehicles.
- A dilution levy may be charged on a purchase or sale of shares in the Fund in some cases. It may be necessary to reduce the difference between the cost of buying or selling the Fund's investments and the Fund's mid-market share price. Any dilution levy charged will be paid into the Fund.
- The Fund's annual report for each financial year will include detail on the exact charges made.
