The Fund is a sub-fund of Smithfield Funds.

Objectives and investment policy

The Fund aims to generate a balance between income and growth through investment in both UK and international markets.

The Fund will invest in:

•other investment funds (regulated and unregulated)

•transferable securities (shares and bonds issued by governments and other organisations)

•warrants

·cash, money market instruments and deposit

Typically investments will include funds investing into renewable energy projects, infrastructure, high yielding, high risk debt strategies and absolute return funds.

The Fund will target its investment into a range of collective investment schemes and transferable securities that invest into asset classes that seek to have a low correlation to global equity markets and have a more consistent return profile.

The Fund may potentially invest predominantly in the units or shares of other collective investment schemes.

The Fund may use derivatives for Efficient Portfolio Management (EPM), i.e. to protect against market or currency movements, to reduce costs, or to earn income or capital.

Any income the Fund generates will be paid out to you.

You can buy and sell shares from Monday to Friday where these days are business days.

The Fund is actively managed, which means that the manager has discretion over the composition of its portfolio, and the Fund is not tracking a benchmark nor is the Fund constrained by the value, price or components of a benchmark or any other aspect. The Fund is also not aiming to match or exceed the return of any benchmark.

Risk and reward profile

The Risk and Reward Indicator table demonstrates where the Fund ranks in terms of its potential risk and reward. The higher the rank the greater the potential reward but the greater the risk of losing money. It is based on past data, may change over time and may not be a reliable indication of the future risk profile of the Fund.  The Fund is in a higher category because the price of its investments have risen or fallen frequently and more dramatically than some other types of investment. The category shown is not guaranteed to remain unchanged and may shift over time. Even the lowest category does not mean a risk-free investment.

Risks associated with property investment, may include fluctuations in land prices, construction costs, interest rates, property yields, changes in taxation, legislation changes in landlord and tenant legislation, environmental factors, changes in the supply and demand for property.  The Fund is entitled to use derivative instruments for EPM. Derivatives may not achieve their intended purpose. Their prices may move up or down significantly over relatively short periods of time which may result in losses greater than the amount paid. This could adversely impact the value of the Fund. The organisation from which the Fund buys a derivative may fail to carry out its obligations, which could also cause losses to the Fund.

• The Fund may invest in securities not denominated in sterling, the value of your investments may be affected by changes in currency exchange rates. If there are significant requests for redemption of shares in the Fund at a time when a large proportion of the Fund's assets are invested in illiquid investments (which are assets that may at times be hard to sell), there is a risk that there may be a delay in the investments being sold or the price at which they are sold may adversely affect the value of the Fund's ability to settle redemptions could be impaired and it might be necessary to suspend dealings in shares in the Fund and in such circumstances investors may experience a delay or receive less than expected when selling their investments.



- The ongoing charges figure is a representation of the charges taken from the Fund over a year. The estimated ongoing charge of 0.58% is based on the current Investment Management Charge of 0.35%. Should the maximum Investment Management Charge of 0.55% per annum of the Net Asset Value (NAV) of the Fund be charged in future, the estimated ongoing charges figure would be 0.78%.
- Previously, the Ongoing Charges Figure (OCF) included expenses incurred by a Fund on any investments in collective investment schemes and closed ended vehicles such as investment trusts (the synthetic OCF). Following guidance issued by the Investment Association on 30 November 2023, any synthetic OCF now excludes the expenses of closed ended vehicles.
- A dilution levy may be charged on a purchase or sale of shares in the Fund in some cases. It may be necessary to reduce the difference between the cost of buying or selling the Fund's investments and the Fund's mid-market share price. Any dilution levy charged will be paid into the Fund.
- The Fund's annual report for each financial year will include detail on the exact charges made.
