BMO LGM Responsible Asian Equity Fund

Class B USD Accumulating Shares (ISIN IE00B2R8GQ87), a sub-fund of BMO Investments II (Ireland) plc. This Fund is managed by KBA Consulting Management Limited (the "Manager")

Objectives and investment policy

The Fund aims to provide long-term capital growth.

It seeks to do so by investing mainly in equity securities (shares) of companies established in, or deriving a significant amount of their activities in Asia. The Fund selects quality companies based on four key criteria: sustainable business models; robust balance sheets; proven management teams; and a clear alignment of interest between majority and minority shareholders.

The manager will only invest in companies that demonstrate a clear commitment to Good Governance and Sustainability. Companies will be required to meet standards, including board balance and independence, transparency and disclosure and the protection of shareholder rights. They must also demonstrate a clear commitment to sustainable environmental and social practices. A number of screens are also applied based on specific revenue thresholds so that certain companies that are connected to tobacco or alcohol, gambling, nuclear power generation, oil, gas and coal reserves, pornography and controversial weapons will be excluded.

The Fund may use derivatives to gain exposure to its target markets and manage risk. A derivative is a financial instrument whose value is based on the performance of another financial asset, index or investment.

The Fund is actively managed. The Fund is not constrained by its comparator benchmark, the MSCI AC Asia ex Japan (NR) Index and has significant freedom to invest in a portfolio that is different to the benchmark's own composition.

Income generated by the Fund will be reinvested by the Fund to increase the value of your investment. There is no minimum holding period for this Fund. However, it may not be appropriate for investors who plan to withdraw their money in under 5 years.

You may buy or sell shares on demand (but not weekends or Irish bank holidays or other days when the Fund is not open for dealing). Orders to buy or sell must be received before 11.00 am (Dublin time) on a dealing day to receive the price calculated at that day's valuation point.

Risk and reward profile

The Risk and Reward Indicator table demonstrates where the Fund ranks in terms of its potential risk and reward. The higher the rank the greater the potential reward but the greater the risk of losing money. It is based on past data, may change over time and may not be a reliable indication of the future risk profile of the Fund. The shaded area in the table below shows the Fund's ranking on the Risk and Reward Indicator.



The risk category is based on historical data and may not be a reliable indication of the future risk profile of the Fund. The risk category shown is not guaranteed to remain unchanged, and it may shift over time. The lowest risk category does not mean the investment is "risk free".

The Fund may also be exposed to other risks that the risk indicator does not adequately capture. These may include:

Market Risk: the value of assets held by the Fund may go down as well as up. There can be no assurances that the investment objective of the Fund will be achieved.

Currency risk: investing in assets denominated in a currency other than the Fund's currency exposes the value of the investment to exchange rate fluctuations.

Liquidity risk: the Fund may not be able to sell or buy certain investments at a suitable time or at a reasonable price.

Counterparty risk: a counterparty to a financial contract with the Fund could fail to return money or instruments belonging to the Fund.

Derivatives risk: where derivatives are used to obtain, increase or reduce exposure to an asset, index or investment, these derivatives may have an impact on the Fund's risk profile.

Ethical Screening Risk: the screening out of sectors or companies on governance, sustainability and ethical grounds may mean the Fund is more sensitive to price swings than an equivalent un-screened fund.

Charges


